## Instructor Indemnity Scheme proposal form

### Summary of cover

This policy will meet the demands and needs of someone who wishes to provide protection for costs and damages they may become liable to pay for injury to Third Parties arising out of their instructions, demonstrations or supervision of martial arts activities.
